GENERAL INFORMATION

- This competition is NCDCTA recognized and will be conducted in accordance with USEF rules except dress code is waived.
- Braiding and coats are not necessary. Hard hats with harnesses are required.
- Management reserves the right to split, cancel, or combine classes and add or substitute judges. Classes to be divided JR/SR where warranted.
- Proof of negative coggins required. Coggins will be kept on file throughout the show year. Coggins are not kept after the Nov. show.
- NUMBERS will now be given at the shows. Fee will be refunded upon return of number.**
- Concessions will be available on the show grounds. Also, M&M Tack Shop will be open.
- Limited stabling is available. \$30/day or night. Reservations required.
- Times are available Thursday before the show after 12:00 p.m. until Friday at 5:00 p.m. at 851-1118 or 851-1171, and on Saturday from 9-5 at 851-0102 (M&M Tack Shop). Times will be available on the website. Click Horse Shows then scroll for Dressage times.
- Late entries will be accepted as space permits with an extra \$5.00 late fee. No scratch refunds after closing date unless time can be filled. Payment not received with entries charged \$5 late fee. Call, email or fax if questionable for entries to arrive on time. We recommend you call or email to confirm receipt of faxed entry. Returned Checks will be charged a \$30.00 fee.**
- Entries scratched without payment will not be allowed to enter other shows until paid.**
- Arenas: CT, USDF and USEF Training Level 1-3 will be in 20x40 arena, all others in standard 20x60 arena. Sand warm up arena.
- Awards: Six ribbons are awarded for each class and combined tests.

We will offer end of year awards for riders who compete in at least three shows.
