

COVID-19 policies for 2020 Summer Day Camps

****In accordance with the NC Department of Health and Human Services: Interim COVID-19 Guidance for Day Camp or Program Settings Serving Children and Teens**

1. Communication to parents, campers, and staff prior to camp start
 - MacNair's has provided staff with education and training on COVID-19 strategies
 - MacNair's will communicate to parents/families related instructions in preparation for camp opening including keeping children home if showing any signs of illness, and instructing children on proper use of facemasks and social distancing guidelines.
2. Drop off/arrival procedure
 - A staff member will greet children outside when they arrive while limiting direct contact with parents as much as possible.
 - Staff will monitor and discourage congregation.
 - Designated staff will walk children to the Camp Building upon arrival and walk them to their cars at the end of the day.
 - A hand hygiene station will be set up at the entrance of the Camp Building so that staff and children can wash their hands before they enter.
3. Prevent virus that causes COVID-19 from entering the building
 - Signage will be posted to remind campers and staff of physical distancing.
 - Each group of children will be restricted to one room.
4. Preventing the spread of the virus in the camp/program facility
 - Staff will advise campers to stay 6 feet apart throughout the day and avoid touching eyes/nose/mouth, and cover coughs/sneezes with the elbow.
 - Proper guidance will be followed to ensure campers and staff wash hands upon arrival in the morning, before/after eating lunch, after blowing noses/coughing/sneezing, and after toileting
 - Hand sanitizing products with alcohol will be set up at the entrance of the Camp Building and at the stable.
 - Signage will be posted to remind campers and staff of physical distancing
 - The Camp Building will have 6 feet spacing markings- floors will be marked
 - Groups will include the same children each day- several full day campers may need to combined into new groups when half day campers leave.
 - Each group of children will be in a separate room while in the Camp Building
 - Campers will not participate in activities in which they cannot maintain social distancing
 - Ventilation systems in the Camp Building have been checked and are operating properly. If not too hot, windows and doors will be opened to increase air flow.
 - Staff members will wear cloth face coverings when in the Camp Building and when unable to maintain at least 6 feet distance outdoors. Campers
 - Campers will be required to wear cloth face coverings when inside the Camp Building. Campers will not be required to wear facemasks when riding or participating in other outdoor activities in which they can social distance.
5. Sanitation and hygiene practices
 - Frequently touched surfaces shared equipment will be cleaned and disinfected throughout the day and at the end of each day- shared use of supplies and equipment will be minimized.
 - Alcohol based hand sanitizer will be at the entrance of the facility, entrance of the camp building, and stabling area. Hand sanitizer, soap, and paper towels will be routinely checked and refilled
 - Bathroom and handwashing breaks will be incorporated.
6. Children or staff who develop symptoms during the day
 - If a child or staff member develops any symptoms of COVID-19 MacNair's will send them and any family members home as soon as possible.
 - While waiting for a sick child to be picked up, staff will stay with the child in a room or outside area isolated from others. If the child has symptoms of COVID-19 staff will remain as far away as safely possible from the child while maintaining visual supervision. Staff will wear a cloth face covering and the child should also if tolerated.
